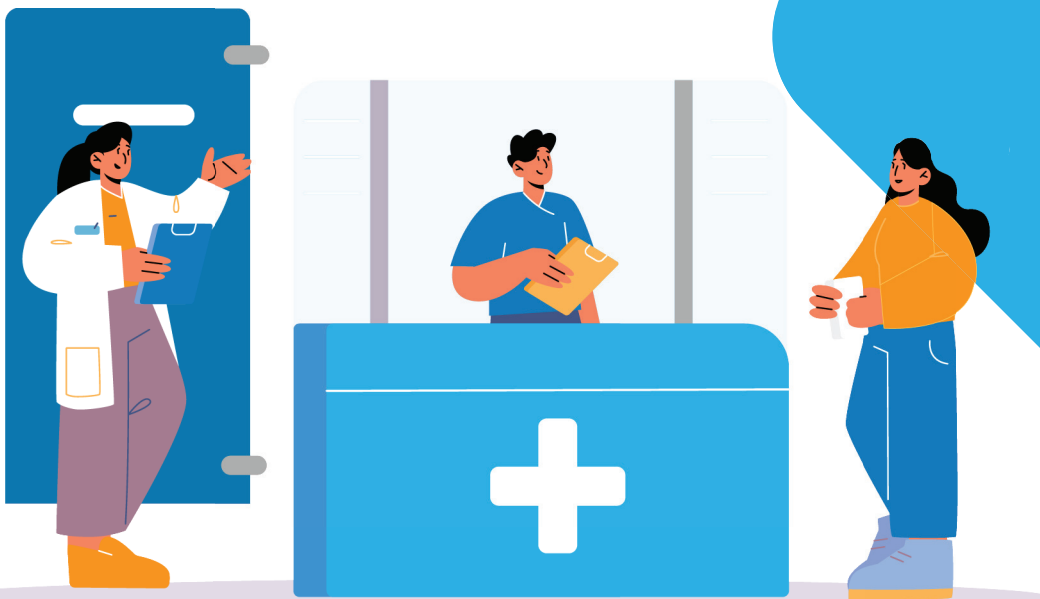

Customizable Intake Queue

- Electronic Rx queue
- Refill queue
- Document queue
- Incoming fax queue.

This provides the pharmacist with a comprehensive view of all prescription fill needs, allows for prioritization, and facilitates batch group processing.



Prior Authorization Management

The system transmits prior authorization requests directly to Surescripts® and CoverMyMeds® via the system's electronic messaging function. Each prior authorization request is tracked, with the outcome automatically added to the patient's record.

Electronic Signature Capture

Pharmacies are legally responsible for capturing, validating, and maintaining patient signatures. Electronic Signature Management helps pharmacies easily meet these requirements. One less thing for pharmacists to worry about.

Key Features



Easy, HIPAA-Compliant Signature Capture

- Patients provide signatures at point-of-sale. Signatures are automatically scanned and linked to the patient's record within our point-of-sale module.
- A single signature can be used for multiple prescriptions.
- Allows for family member medication pickups.



Signature Validation

Consistent with HIPAA requirements, signatures are automatically date/time stamped at point of collection. Signatures can easily be collected for a wide range of pharmacy purposes including:

- HIPAA requirements.
- Easy-off cap requests.
- Counseling.
- Auto-Refill programs.
- Third party release authorizations.



Notice of Privacy Policy

- Determines if the patient has signed the pharmacy's Notice of Privacy Policy (NOPP). If the policy has not been signed, the system provides a place for the patient to sign and confirm receipt of the NOPP.
- Tablet/iPad capability
 - No longer must pharmacy staff be tethered to a point-of-sale electronic signature pad. Instead, the solution allows electronic signature functionality via a tablet or iPad. This feature is especially helpful for home deliveries, and in managing pharmacy drive-thru windows.
- Records management
 - Pharmacy managers can easily retrieve signature logs, for easy compliance with audit requests and internal reporting needs.
- Data encryption/Security
 - The solution offers the highest levels of security, which includes encryption of all data, and strict log-in protocols for all system users.

- Ability to process patient copays via a debit or credit card.
- Ability to generate a receipt for each copay collected.
- Seamless reconciliation of all transactions with overall pharmacy operations.

HIPAA-Compliant Signature Collection

- Patients can sign once for multiple prescriptions and uncheck specific scripts if they do not wish to take delivery of them at that time.
- Patients can sign for prescriptions ahead of time, which allows medications to be delivered even if no one is home to accept the shipment.
- Data is encrypted and remains highly secure while in transit.

- Collect and manage patient signatures at the pharmacy drive-thru, curbside, or during delivery to a patient's home.
- Driver can access delivery information while in-transit by scanning an Rx number or facility code into a mobile device.
- Manage multi-store deliveries.

- Google Maps identifies each delivery location and generates an optimal route.

How Does it Work?

The portal has four types of login users: **Pharmacy Admin, Facility, Doctor, and Salesperson.**

- The pharmacy admin manages access to the web portal along with content on all tabs.
- Facility users can have access to certain patient records in PrimeRx via a facility code that grants authorization.
- Each doctor's login is limited to prescriptions written by that individual for a particular patient.
- The salesperson login allows the user to view information connected to a designated prescriber. Sales personnel can be attached to specific prescribers, with all pairings tracked by the pharmacy administrator. A convenient dashboard allows sales personnel to track the status of prescriptions within the pharmacy workflow.

Central Management Portal

Address the unique needs of multiple pharmacy owners with a single-platform technology system.

Our solution addresses the critical need for multi-pharmacy owners to have visibility both at the individual store level, and across the entire organization. We also allow each store to “talk” to each other, via a single, connected platform.

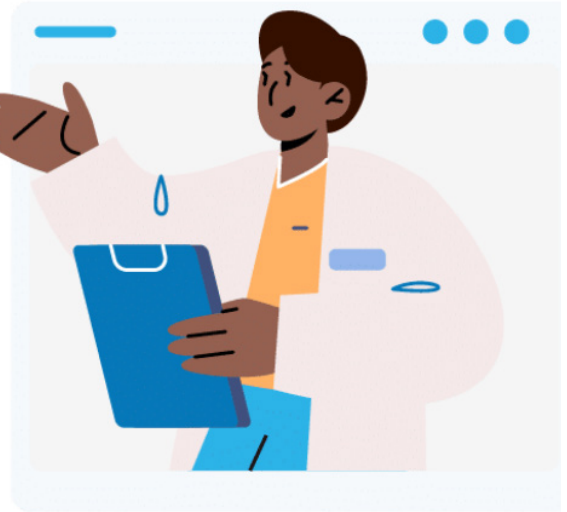

Remote Backup Service (RBS)

Protects data from unexpected disruptions and loss. RBS uses the Amazon Elastic Compute Cloud (Amazon EC2) to store data generated from within PrimeRx software applications.

How Does it Work?

-  **Refill requests** are processed and automatically loaded to the PrimeRx refill queue.

During checkout, the patient can specify their preferred pickup/delivery option:

Delivery to the patient's preferred address on a specific date.

In-store pickup at a time/date specified by the patient.

-  **The patient** is notified when a refill request is successfully received and again when the prescription has been filled.

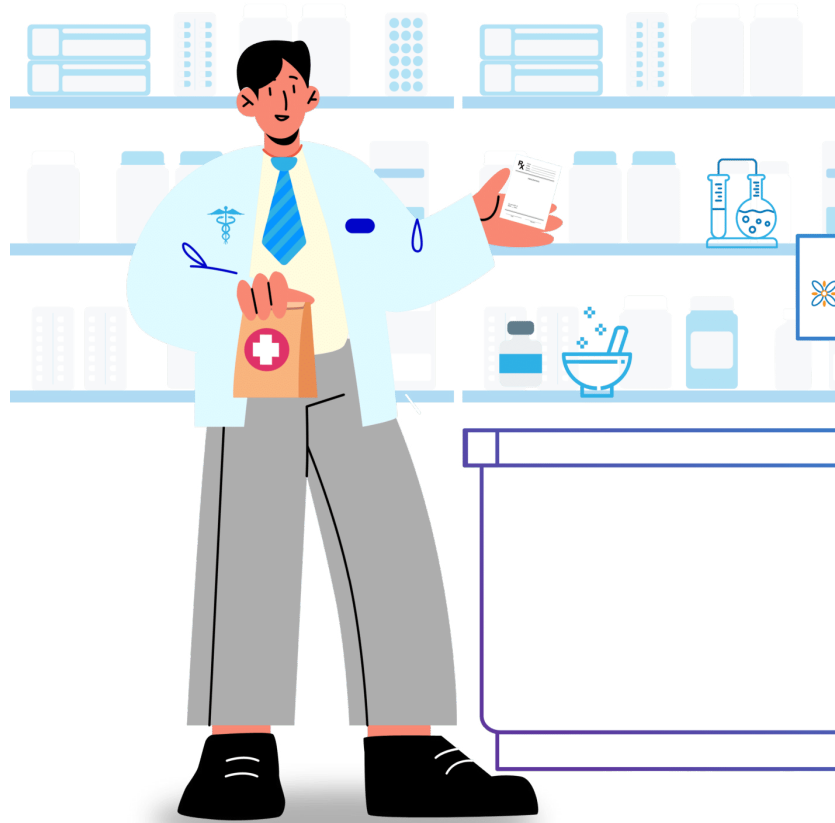
